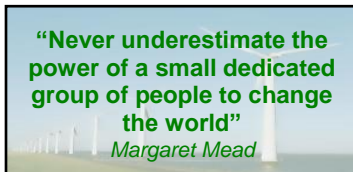

I understand that I have a 30-day money-back guarantee on products and that no refunds for services are provided and credit card / debit card CHARGEBACKS / DISPUTES FOR SERVICES ARE PROHIBITED. I understand I am signing a contract, I agree that I will not dispute charges for services I have agreed to pay by signing this agreement. I can cancel month-to-month services at any time with written notification, and I am responsible for paying the entire amount of long-term contracts (such as Bronze, Silver, Gold, GreenlineSM, and Planet Patron) even if I cancel any of the services or return products after the period allowed as listed on the KP website.
